
Effective from 1 July 2024, waste disposal facility operators, including transfer stations and landfills, are required to record and report on the activity category of the materials their facility receives.

- 4. Residential Kerbside Collection
- 5. Residential Drop-off
- 6. Unusual Activity. Used only as an exception to capture waste that does not fit into the other categories.
- 7. Transfer Station mixed activities. Waste or diverted material that enters a facility from a transfer station.
